WHEREAS, presented for deliberation was a letter dated July 4, 2022 from Project Engineer Shaimah B. Amerol of the Department of Public Works and Highways, Lanao del Norte, First District Engineering Office requesting for the implementation of the proposed traffic scheme to avoid traffic build up in the area and public inconvenience for the implementation of the construction of the project "22KF0004 – Replacement of Permanent Weak Bridge at Baslayan Bridge 1 (B00983MN) along Tibanga Road – Pala-o Junction, Iligan City";

## CITY ORDINANCE NO. 22 - 7183

AN ORDINANCE AUTHORIZING FOR THE TEMPORARY CLOSURE OF MARIANO BADELLES SR. STREET SPECIFICALLY ALONG THE BASLAYAN CREEK AND ROXAS AVE FROM INTERSECTION OF QUEZON AVENUE TO GENENERAL WOOD STREET, DUE TO THE IMPLEMENTATION BY THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) OF PROJECT "22KF0004 – REPLACEMENT OF PERMANENT WEAK BRIDGE AT BASLAYAN BRIDGE 1 ALONG TIBANGA ROAD-PALA-O JUNCTION" WHICH WAS STARTED ON JULY 4, 2022, UNTIL THE COMPLETION OF THE PROJECT.

Be it ordained by the Sangguniang Panlungsod of Iligan City in its session assembled, that:

**SECTION 1. -** There is **AUTHORIZED**, as the same is hereby **AUTHORIZED** for the temporary closure Mariano Badelles Sr. Street specifically along the Baslayan Creek and Roxas Ave from intersection of Quezon Avenue to Gen. Wood Street.

SECTION 2. ROADS TO BE CLOSED & ONE WAY STREET

Road Closure:

**MARIANO BADELLES SR. STREET** – from Junction Road of Sabayle Street to intersection road of Mariano Actub Street.

One way Street:

**MARIANO ACTUB STREET** – from intersection road of Benito Labao Street to Mariano Badelles Sr. Street and intersection of Mariano Actub Street.

**LABAO STREET** – from intersection road Marianito Actub Street to intersection road of Sabayle Street.

**SECTION 3.** – <u>ROUTE FOR HEAVY DELIVERY TRUCKS/TRAILER BED/BUSES and</u> other PUJ –

From North to South:

<u>HEAVY TRUCKS/TRAILER BED/BUSES</u> – shall keep right to Mariano Badelles Sr. Street, turn right to Sabayle Street, left turn Cabili Avenue, left turn Quezon Avenue, right turn Mariano Badelles Sr. Street to Tambacan Proper, left turn Pedro Celdran Avenue, right turn Diosdado Macapagal Avenue to their destination.

From South to North

Proceed to Macapagal Avenue to Roxas Avenue then Andres Bonifacio Avenue to their destination.

**ALL PUJ** – North Operation:

From point of origin to Andres Bonifacio Avenue keep left Roxas Avenue, right turn Marianito Actub Street, right turn Actub Street, left turn Sabayle Street,

left turn Cabili Avenue, right turn Quezon Avenue, left turn G.W. Nanaman Road, Gen Emilio Aguinaldo Street to their destination.

**SECTION 4. Effectivity –** this Ordinance shall take effect upon its approval.
