**WHEREAS**, they partnered with Manila Auto Club Ph by organizing an automotive exhibition entitled; "Iligan/Rave Party Auto Moto Exhibit"; on July 31, 2022;

**WHEREAS**, since Cabili Avenue and the surrounding streets are presently used by vehicles, there is a need to temporarily close it, in order for the organizer to perform the activity unhampered;

**CITY ORDINANCE NO. 22-7192**

**AN ORDINANCE AUTHORIZING FOR THE TEMPORARY CLOSURE OF PORTION OF CABILI AVENUE FROM ROTUNDA TO THE INTERSECTION OF QUEZON AVENUE (ONE SIDE ADJACENT LUDO BUILDING ) ON JULY 31, 2022 FROM 9:00. A.M. TO 10:00 P.M., FOR THE "ILIGAN/RAVE PARTY AUTO MOTO EXHIBIT" HOSTED BY LMNTRX EVENTS PRODUCTION**

Be it ordained by the Sangguniang Panlungsod in its session assembled, that:

**SECTION 1.** - There is **AUTHORIZED**, as the same is hereby **AUTHORIZED** for the temporary closure of Cabili Avenue from Rotunda to the Intersection of Quezon Avenue (*One side adjacent Ludo Building*) on July 31, 2022 from 9:00 A.M. to 10:00 P.M., for the "*Iligan/Rave Party Auto Moto Exhibit*" hosted by LMNTRX Events Production.

**SECTION 2.** - The organizer is hereby required to observe the following:

1. Observe Social distancing ( 2feet) or six (6) meters from other people
2. Wear face masks
3. Observe the "*No Face Mask, No Vaccination Card No Entry*" Protocol
4. Prevent the entry of those whose temperature is more than 37.5C
5. No Smoking
6. Comply all other requirements as stipulated in their request

**SECTION 2.** - The Iligan City Traffic Division is hereby required to provide traffic officers to monitor, direct and control traffic along the area to maintain smooth flow of vehicular traffic during the auto show.

**SECTION 3. Effectivity** - This Ordinance shall take effect upon its approval.
