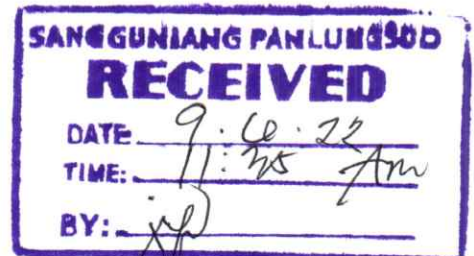

RESOLUTION NO. 22-593

WHEREAS, City Vice Mayor Marianito D. Alemania, Presiding Officer of the Sangguniang Panlungsod will be on Official Business within this week, to transact business with other Local Government Unit leaders, for the benefits of the people of Iligan City;

WHEREAS, by virtue of being an elected City Vice Mayor, Vice Mayor Alemania, is authorized by the Local Government Code to sign checks, payrolls, vouchers for the payment of wages and salaries, among others of the personnel and officials working in the Sangguniang Panlungsod;

WHEREAS, unless somebody is authorized and delegated to sign the Sangguniang Panlungsod's checks, payrolls, vouchers and other documents, the processing of these documents will be adversely affected and delayed;

WHEREAS, City Councilor Bernard Y. Pacaña, the First Councilor of the 18th Council, has no planned official business this week outside of Iligan City, hence the need to authorize him to sign the abovementioned documents, in behalf of City Vice Mayor Alemania;

CITY ORDINANCE NO. 22-7207

AN ORDINANCE AUTHORIZING CITY COUNCILOR BERNARD Y. PACAÑA, FIRST COUNCILOR OF THE 18TH COUNCIL, TO SIGN AND APPROVE DISBURSEMENT VOUCHERS, CHECKS, PAYROLLS AND OTHER NEGOTIABLE INSTRUMENTS, AMONG OTHERS OF OFFICIALS AND EMPLOYEES IN THE SANGGUNIANG PANLUNGSOD, WHILE CITY VICE MAYOR MARIANITO D. ALEMANIA IS ON OFFICIAL BUSINESS, AND TO FURNISH COPY OF THE SPECIMEN OF HIS SIGNATURE TO ALL DEPOSITORY BANKS WHERE THERE ARE DEPOSITS OF THE CITY GOVERNMENT, AS A MEANS OF DISBURSING THE SANGGUNIANG PANLUNGSOD FUNDS

Be it ordained by the Sangguniang Panlungsod of Iligan in its session assembled, that:

SECTION 1. - City Councilor Bernard Y. Pacaña, First Councilor of the 18th Council is **AUTHORIZED**, as he is hereby **AUTHORIZED** to sign and approve disbursement vouchers, checks, payrolls and other negotiable instruments, among others of officials and employees in the Sangguniang Panlungsod, while City Vice Mayor Marianito D. Alemania is on Official Business.

SECTION 2. - City Councilor Pacaña is **AUTHORIZED**, as he is hereby **AUTHORIZED** to furnish copy of the specimen of his signature to all depository banks where there are deposits of the Iligan City Government, as a means of disbursing public funds for the Sangguniang Panlungsod, which includes accomplishment of the required forms to realize the foregoing authority.

SECTION 3. Effectivity - This Ordinance shall take effect upon its approval.
